Since 2011 have been working nationally and locally as a presenter, consultant, trainer, and facilitator with a number of jurisdictions, agencies and public systems, including the New York Office of Children and Family Services, New York Administration for Children, the National Council of Juvenile and Family Court Judges; Casey Family Programs; Missouri Department of Mental Health; Missouri Department of Social Services' Children's Division and St. Louis Public Schools. The focus has been on providing support to promote racial equity; systemic reform; and the achievement of better child, family and community outcomes. The equity work includes:

- Designing and implementing a racial equity curriculum;
- Providing single and multi - day, multi-level staff development training and facilitation sessions for agencies and organizations; and
- Providing ongoing multi-level technical assistance and consultation for agencies and organizations.

**Criminal Justice Reform***March 2017 – Present**Director of Community Engagement and Strategic Partnerships, Circuit Attorney, City of St. Louis*

Since March 2017, began working for the first African American female Circuit Attorney (Prosecutor) in the City of St. Louis, MO, to help design and implement an aggressive criminal justice reform agenda that takes a public health approach toward increasing public safety, reducing harm, and restoring trust in the criminal justice system to reduce crime and violence.

Duties include:

- Co-designing, implementing and managing the alternative prosecution diversion program for first time non-violent adult and youthful offenders;
- Co- designing and implementing three diversion centers at an elementary, middle and high school to provide prevention programming aimed engaging students and families in efforts to close the ‘school to prison pipeline’ and reducing their potential involvement in criminal activity;
- Developing and implementing strategies and services that include: identifying and engaging service providers to provide behavioral and physical health service to defendants involved in the diversion programs; helping establish witness protection and relocation supports and network for those who will testify against violent offenders; increasing citizens’ participation and awareness toward improving how the criminal justice system works in order to restore trust; co-convening weekly homicide trauma support groups for family survivors of gun violence; and working to increase resident involvement in the design and implementation of neighborhood crime reduction strategies.

**Service Integration and Wrap-Around Services***May 2013- March 2017**Coordinator, Full Service Schools, St. Louis Public School District*

Since May 2013, have been providing ongoing administrative oversight and coordination on a part- time basis in the four Full Service Schools in the St. Louis Public School District. The approach delivers wrap around services and supports during and after school to support students whose attendance, behavior and academic achievement are adversely impacted by their chronic exposure to poverty, family and/or community violence, trauma and toxic stress. Establishing and maintaining partnerships with various community mental and physical health service providers is an important component of this effort. Duties include:

- Developing and monitoring overall programmatic design;
- Ensuring ongoing community engagement and related community partnerships;
- Securing and maintaining ongoing funding and resource supports; and
- Hiring and supervising several full-time and part-time staff.

**Building Community Partnerships in Mental Health**  
*Co-Coordinator, St. Louis City and County Resilience Coalition, Missouri Department of Mental Health*

*September 2014 – June 2016*

Worked for and with the Missouri Departmental Health on a part-time basis to establish and co-lead an initiative called the St. Louis North City and County Resilience Coalition. The initiative was created by the Governor of Missouri in the wake of civil unrest that occurred after the death of Michael Brown in Ferguson, Missouri in August 2014. The Resilience Coalition was charged with identifying and implementing short and long term strategies to address the barriers and stereotypes experienced by African Americans who were in need of and desirous of having better access to culturally competent emotional and behavioral health services. The primary duties included:

- Developing and implementing a framework model called Listening Session Model to help participants better understand the intersections of race, poverty, trauma and toxic stress;
- Conducting community engagement and outreach to schools, agencies and faith community representatives; and
- Convening regular meetings with agency stakeholders to identify and address barriers to service delivery and effectiveness in minority communities.

**Child Welfare Reform Initiative Work**

*October 2003 — May 2011*

*Senior Fellow, Center for the Study of Social Policy in Washington, DC*

Developed and implemented a national, multi-year campaign to address and reduce racial disparities and the disproportionate representation of children from certain racial or ethnic communities in the nation's child welfare system. Duties have included:

- Developing and coordinating a theory of change framework;
- Testifying before Congress, and convening several Congressional staff briefings;
- Convening key leaders and funding partners on monthly basis for learning, planning, monitoring and coordination;
- Providing project site supervision, technical assistance and facilitation in several jurisdictions, along with compiling and submitting site progress reports and grant summaries;
- Providing ongoing racial equity training and technical assistance in 34 jurisdictions for the National Council of Juvenile and Family Court Judges; and
- Presenting at national conferences.

- Developing a regional strategy with measurable outcomes for implementation and monitoring;

- Working directly in neighborhoods with neighborhood resident leaders and law enforcement officials, in certain aspects of service delivery related to street gang abatement and drug intervention.
